# **Operations**

- The General Manager (GM) attended Conservation Ontario (CO) sessions on changes to the Conservation Authorities Act (CAA) on April 22<sup>nd</sup>. Ministry of Natural Resources and Forestry (MNRF) staff participated in the meeting to try and answer questions with regard to changes to the CAA specifically with regard to Ministerial appeals and approvals. Specifically, the Minister can now:
  - 1. Make an order to prevent a CA from issuing a permit to an individual (or individuals) to engage in an activity (or class of activities), that would be prohibited under section 28 of the Act;
  - 2. Where an order is made, assume the responsibility for the permitting process in the place of a CA, where the criteria under section 28.1 of the Act concerning natural hazards and public safety can be satisfied; and,
  - 3. Review (and potentially alter) CA permit decisions at the request of the applicant (where the Authority has refused a permit or assigned conditions to the permit that the applicant objects to).

Of greatest concern is item 3 and the potential for the Minister to override local decision making on hazard area planning. It was hoped to have a more detailed report for the June 27<sup>th</sup> meeting but there are further discussions occurring on June 25-26 at a CO senior managers meeting.

 On April 23<sup>rd</sup>, the GM attended a meeting of the Southwest GMs in Cambridge at the Grand River CA head office. Prime topics of discussions centered on approaches to completing Watershed Management Strategies and Conservation Land Management Strategies that are now required by the Province. The SCRCA has completed its draft Conservation Lands Strategy and is currently undertaking public consultation.

- On April 24<sup>th</sup>, the GM attended a Conservation Ontario zoom meeting to discuss the impacts of Bill 185 "Cutting Red tape to Build More Homes Act" and the revised Provincial Planning Statement. Of note is the change for the need to have preconsultation. It has yet to be determined if this will have an impact on CAs preconsultation processes.
- On April 28<sup>th</sup>, the GM attended the Annual Sydenham River Canoe and Kayak Race. Staff did an excellent job in getting the race organized and dealing with the inclement weather. Of note were the number of first-time participants in the race. This event proved to be an excellent means of raising the profile of the SCRCA in the local community. Congratulations to the team of Emery Huszka and Pat Brown for being the biggest fundraisers of the day.
- On May 27<sup>th</sup>, the GM attended a CO zoom meeting concerning the Conservation Lands Strategy approaches across the province. The SCRCA is one of the first to have Board approval of a draft policy and its document is in line with all others at a similar stage.
- On June 9<sup>th</sup> and 10<sup>th</sup>, the GM attended meeting with regard to proposed cut to the Drinking Water Source Protection Program. A verbal update will be provided at the Board of Directors Meeting.
- The GM, along with select staff, attended public open houses for the Conservation Lands Strategy on June 11<sup>th</sup>, 12<sup>th</sup> and 13<sup>th</sup>. The sessions were held at Peers Wetland near Wallaceburg, Bridgeview Park in Petrolia and Coldstream Conservation Area in Middlesex Centre.

## **Community/Partnership Outreach**

- The GM gave an overview presentation at the Lambton Elderly Outreach session in Corunna. He provided an overview the SCRCA and answered questions from the participants.
- On May 28<sup>th</sup>, the GM attended a Sarnia Lambton Chamber of Commerce Green Committee meeting. The focus of the meeting was planning the second annual Canatara Park clean-up event that involved three Sarnia area classes. The event took place on June 4<sup>th</sup>.
- On May 30<sup>th</sup>, the GM attended a tree planting event at the Oil Museum of Canada in Oil Springs. The SCRCA, in partnership with Lambton County, are involved in a multi-year effort to reforest the property. Enbridge provided a number of volunteers to help in the planting. Special thanks to Board Member Mary Lynne McCallum, representing Enniskillen Township, for helping to plant at the event.

## Federal/Provincial/Municipal Meetings

- On May 7<sup>th</sup>, the GM attended Middlesex Day, held in Lucan. The session included information on local business initiatives and successes, as well as a networking opportunity with municipal stakeholders.
- On June 5<sup>th</sup>, the GM, Director of Water Resources and Manager of Conservation Areas attended a meeting with the Municipality of Middlesex Centre and provided an overview on the dam decommissioning study for the Coldstream Conservation Area. Staff answered questions and will be working with municipal staff on a plan of action going forward.

These two vehicles have reached the point where the repair costs to keep them road-worthy far exceed their value. The two vehicles will be disposed of using the GovDeals auction website and proceeds will be placed into the equipment reserve.

# **Background:**

- Starting this year, WECI program will be rolled out in a multi-year format
- This will include for the following fiscal years
  - Year 1 April 1, 2024 to March 31, 2025
  - Year 2 April 1, 2025 to March 31, 2026
- \$5 million of funding available in each year
- Total of 9 projects have been submitted to the WECI program on June 2, 2024
- All applications will be reviewed by a committee, made up of Provincial and Conservation Authority staff representatives, in late March or early April, and will be ranked in comparison to all submitted projects from across the Province
- If funding is confirmed for this program, a list of approved projects may be available in July of 2024
- A list of WECI projects submitted for 2024-2025 is outlined below

• Precipitation amounts for this past spring have been above average for the region

• Water level projections for Lakes Michigan-Huron and St. Clair predict levels will remain above average



- Strathroy experienced a wet May almost doubling the normal amount of precipitation for the month
- Overall the region experienced above normal amounts of precipitation for the past 12 months

### Flood Threat

- As we approach the summer months the flood threat is dependent on intense thunderstorms that have the potential to cause localized flood events
- Thunderstorms have the ability to develop suddenly and can lead to a day's and sometimes a month's worth of precipitation over a few hours
- During these events water levels can rise rapidly which can lead to flash flooding
- The chart below displays the intense summer thunderstorm that the watershed experienced in late August 2023
- The substantial amount of precipitation over a short period of time lead to a significant spike in water levels

### **Lake Levels**

- Water supplies for Lake Michigan-Huron were above average and as a result water levels are above their all-time average for this time of year
- All the great lakes experienced a rise in water levels during May
- Lake Michigan-Huron is expected to continue to rise in June and July with a seasonal decline by August whereas Lake St. Clair is expected to remain near its current level and begin its seasonal decline by June

Figure 2: Lake Michigan-Huron water level forecast (USACE, 2024)







Figure 3: Lake St. Clair water level forecast (USACE, 2024)







# **Spring Outdoor Education Program:**

**Field Trips:** Education team is currently delivering Spring, 2024 Field Trips. Approximately 3,200 students and teachers, from 35 different watershed schools will participate in field trip programs this spring.

**Nature in your Neighbourhood:** The Education Team is currently delivering Spring Schoolyard programming. Approximately 450 students, from 5 watershed schools will participate in Schoolyard programs during Spring, 2024.

# **Special Events:**

Ontario Association of Geography and Environmental Educators (OAGEE) Conference: Education staff were invited to present at the Spring OAGEE conference, held in Sarnia-Lambton May 2<sup>nd</sup> and 3<sup>rd</sup>, 2024. During a bus tour of the area, conference attendees stopped at Lorne C Henderson Conservation Area to learn more about Conservation Authorities and the education programs available to secondary level students.

**St Clair Catholic District School Board (SCCDSB) PA Day:** Education Staff have been asked to present at the SCCDSB's June PA Day. The one-hour session will help promote SCRCA education programs and continue to strengthen relationships with Secondary School teachers in the area.

# **Sponsored Education Program Updates:**

**Aquatic Species at Risk Program:** Funding has been secured for this program for the upcoming 2024-2025 school year through the Aquatic Habitat Stewardship Program grant. This will ensure the program will be offered to watershed schools at no cost.

# First Nations Program Engagement:

Land-Based Education Project at Kettle and Stony Point First Nation: Education staff continue to partner in the development of the school's Land-Based Education Program.

Programming will run weekly until the end of the schoolyear. Education Staff are hopeful to acquire additional funding to ensure this valuable partnership can continue.

Land-Based Education Project at Aamjiwnaang First Nation: Education staff have been invited to participate in a NEW partnership with Aamjiwnaang Kinoomaage Gamig, which is an Elementary school located within this First Nation community. Education staff continue to visit the school monthly to lead Outdoor programming in a nearby forest for students in kindergarten through to grade 4. This partnership will be funded through the existing EcoAction grant.

# SCRCA Conservation Scholarship Program - 2024

The applications are scored based on marks; interest and activities as they relate to conservation and the environment; future studies as they relate to conservation and the environment; reference letter(s); and other comments offered by the applicant.

Applications for the 2024 SCRCA scholarships were due on May 31, 2024. In total, 5 applications were received, however, two of the applications were deemed ineligible. The applications were reviewed by a committee established by the St. Clair Region Conservation Foundation consisting of Joe Faas, Archie Kerr, Ken Phillips, and Donna Blue. The Foundation Board of Directors approved the recommended scholarship recipients at their meeting on June 6, 2024.

# Degradation of Fish and Wildlife Populations – BUI #3

The draft status assessment report for this BUI was completed in October 2023 and the findings were presented to the Canadian Remedial Action Plan Implementation Committee (CRIC) by Environment and Climate Change Canada (ECCC) on November 7, 2023. The CRIC accepted the report findings and recommended that the engagement process commence to have this BUI redesignated to "not impaired". The engagement commenced with a presentation to Aamjiwnaang First Nation Environment Committee on February 20, 2024, and a presentation at the Walpole Island First Nation Heritage Centre Open House on March 19, 2024. Efforts are underway to schedule additional presentations for the First Nation communities.

Restrictions on Drinking Water Consumption or Taste and Odour Problems – BUI #9
Staff are awaiting confirmation from ECCC and MECP (Ministry of the Environment,
Conservation and Parks) that this BUI has been redesignated to not impaired based on the
recommendation in the status assessment report and feedback received during the
redesignation engagement process.

### Loss of Fish and Wildlife Habitat - BUI #14

The RAP Coordinator made a presentation to the CRIC on April 25, 2024, on the status assessment report for this BUI. The report provides information on the outcome of the assessment of the 7 delisting criteria and includes a recommendation that this BUI be redesignated to not impaired based on the outcome of the assessment. A follow-up CRIC meeting is planned for either June or July 2024 to seek the committee's endorsement of the report's recommendation so that community engagement on the recommendation can commence.

# **Management of Contaminated Sediment**

The Ontario Ministry of the Environment, Conservation, and Parks (MECP), with assistance from Environment and Climate Change Canada (ECCC), are taking the lead on outreach activities associated with the implementation phase of this project. Dow has confirmed that it will be leading the implementation work and covering the associated costs. Work is anticipated to be able to occur in the summer of 2024, subject to the required approvals being in place.

# Strategic Objectives(s):

To ensure that our rivers, lakes and streams are properly safeguarded, managed and restored.

# **Financial Impact:**

Funding for the RAP Coordinator position is provided by the Ministry of the Environment, Conservation and Parks (MECP) and Environment and Climate Change Canada (ECCC). Funding was secured from MECP for the 2024-2025 and 2025-2026 fiscal years under their Great Lakes Program.

The funding agreement with ECCC for the period 2023-2024 came to an end on March 31, 2024. An application for funding under the federal Great Lakes Freshwater Ecosystem Initiative Program for the 2024-2025 and 2025-2026 fiscal years was submitted on February 13, 2024. The SCRCA is awaiting confirmation of funding approval.

The RAP Coordinator continues to hold monthly meetings with ECCC and MECP, providing regular updates on the status of the project work.

# **Background:**

The SCRCA owns approximately 1,195 acres of agricultural land within the watershed. Historically, the agriculture lands owned by the SCRCA are rented/leased on a five-year term, as per the *Conservation Authorities Act, R.S.O. 1990, c. C.27*, Section 21.(1)(d). Prior to the last round of tendering, current tenants had the ability to match higher bids. The Board of Directors eliminated the matching of bids for the 2021 tender process.

These lands generate income, helping to offset salary costs and other budget items. Staff continue to seek grants and programs to reduce the overall budget for these lands.

Based on the last tendering process, the Board of Directors approved an agriculture task team to review the Agriculture Lease Agreement. During theses meetings, the task team reviewed the Agreement template and posed several questions to staff. As a result, the task team and staff are working on an improved approach, which will aim to achieve a balance of revenue and sound environmental management on these lands.

The SCRCA, for many years, has promoted and provided grants for stewardship activities and best management practices throughout the watershed. Landowners in the watershed, especially in the McKeough Upstream lands area, have commented that we are not necessarily implementing these best management practices on our own lands. From those comments and suggestion from the task team, staff will be focusing on integrating appropriate best management practices to improve the land management on these properties. This will include developing an agriculture land strategy, new lease agreement and tender package, an internal land category inventory for management, and priority list for improvements.

Goal 3.4 Healthy Watersheds and Stewardship

Through various outreach and granting programs, stewardship projects and Best Management Practices are encouraged on private and public lands for the overall benefit of improved water quality and terrestrial and aquatic habitat.

Dear Mayor Bradley, the Honourable Steven Guilbeault, the Honourable Diane Lebouthillier and those included from the Parks and Recreation Department amd our local Conservation Authority,

I hope this email finds you well.

I am writing to express my deep concerns regarding the lack of care and attention given to the federally protected killdeer that are currently nesting at the Point Lands. As a concerned citizen and advocate for conservation efforts, I believe it is imperative that immediate action be taken to address this issue.

Killdeer, protected under federal law, are vital members of our local ecosystem and play a crucial role in maintaining ecological balance. Their nesting habitats are of utmost importance for their survival and the preservation of biodiversity in our community. However, recent observations have shown a disregard for these protected species at the Point Lands, posing a threat to their well-being and the integrity of their nesting grounds.

Conservation facts underscore the significance of protecting killdeer and their habitats:

# Re: Recommended phase out of free well water testing in the 2023 Auditor General's Report

Dear Minister Jones:

The Long Point Region Conservation Authority is concerned with the Public Health Ontario's recommendation of phasing out free water testing.

The Long Point Region watershed has a total population of approximately 100,000 people. Of those, approximately one-third rely on private water sources for their drinking water supply. These private water sources include personal wells and sand points which are not actively monitored. With the recommendation to discontinue free water testing, we fear many residents will not undertake regular testing and will be put at risk.

At the May 1<sup>st</sup> meeting of the Long Point Region Board of Directors, the following resolution was unanimously approved:

Motion No.: A-69/24

Moved By: Chris Van Paassen Seconded By: Tom Masschaele

**WHEREAS**: private water systems (e.g., wells) are not protected through legislated requirements under The Safe Drinking Water Act 2002 and The Clean Water Act 2006, but are more likely to contribute to cases of gastrointestinal illness than municipal systems;

**AND WHEREAS**: the 2023 Ontario Auditor General's value-for-money audit of Public Health Ontario (PHO) recommended that PHO, in conjunction with the Ontario Ministry of Health, begin the gradual discontinuance of free private drinking water testing;

**AND WHEREAS**: in the jurisdiction of LPRCA, many households do not receive water from municipal systems, with many relying on a private drinking water system, including wells;

**AND WHEREAS**: the Walkerton Inquiry Report Part II, concluded the privatization of laboratory testing of drinking water samples contributed directly to the E. coli outbreak in Walkerton, Ontario in May 2000;

**AND WHEREAS**: all Ontarians deserve safe, clean water, and free well-water testing is a way to help ensure that residents on private wells continue to have barrier-free access to well water testing.

**THEREFORE, BE IT RESOLVED THAT**: the Board of Directors calls on the Province to not phase out free well-water testing as part of the proposed streamlining efforts of public health laboratory operations in the province;

**AND FURTHER THAT**: this resolution be circulated to the Hon. Sylvia Jones, Minister of Health; Hon. Lisa Thompson, Minister of Agriculture, Food and Rural Affairs; Hon. Andrea Khanjin, Minister of the Environment, Conservation and Parks; local MPPs; and Conservation Ontario and Ontario's conservation authorities.
