## **Position Summary**

The St. Clair Region Conservation Authority (SCRCA) is looking to add to their team, a Conservation Area Maintenance Foreperson. The Maintenance Foreperson is responsible for the general maintenance of all facilities, grounds, and structures within the assigned Conservation Area. Work outside and enjoy the summer weather alongside great people and co-workers. SCRCA offers a professional, safe, and fun working environment.

#### **Duties and Responsibilities**

- Maintain all grounds, washrooms, buildings, trails, and roadways
- Operate pump out equipment to remove sewage from trailer holding tanks in accordance with safe operating practices
- Assist with the enforcement of Authority rules and regulations
- Assist the general public by providing information on policies, regulations, facilities, and general park information
- Assist with the collection and accounting of Conservation Area fees and campsite reservation system
- Assist with camper communication
- Operate all equipment and vehicles in a safe and responsible manner
- Perform other duties as assigned

- Must possess a valid class G driver's licence; successful candidate will be required to provide a MTO Driver's Abstract
- Experience operating equipment (riding mower, trimmer, tractor, etc.)
